NOTIFICATION

Nagaland Education Project – The Lighthouse (NECTAR) under Component 2 “*Enhancing the Teaching and Learning Environment*” of the project design, executed a thorough and careful evaluation of all the government schools in the State for the selection of 16 Lighthouse School Complexes (one per district). One of the key elements of the Nagaland Education Project – The Lighthouse (NECTAR) project is the creation of Lighthouse School Complexes (LSC), as envisaged by National Education Policy (NEP), 2020. The NEP 2020 reinforces the concept of a school complex model in India and the Directorate of School Education (DoSE) under the NECTAR project will establish one LSC across each of the sixteen districts in the State, which will be centers of excellence with self-sufficient and sustainable model; and be a strong model that will not only improve the quality of education but also strengthen society through active community engagement. All the sixteen LSCs have been identified through a rigorous four-stage selection process involving multiple stakeholders at the district and state levels and approved by the State Committee for Light House School Complex (SCLSC). After exercising all due diligence and receiving approval on the site assessment and geotechnical feasibility test and also ensuring that these schools align with the objectives and vision of the project, the selected 16 Lighthouse School Complexes are presented below:
